## FREQUENTLY ASKED QUESTIONS

### WHAT IS A BRACKET?

A bracket is comprised of teams that have qualified to participate in the NCAA Men's Basketball Tournament. The single-elimination tournament results in two teams competing in the Championship Game on Monday, April 7, 2026. To fill out your bracket, simply select the teams that you think will win each game during the tournament up to the Championship Game. If you are a basketball novice, you can use either our PICK FOR ME button to fill out your bracket with randomly selected teams or our FAVORITES button to fill out your bracket with the highest-seeded teams. Regardless of how you fill out your bracket, be sure to click SUBMIT after you are done to ensure that your bracket is recorded in the system.

### HOW DO I ACTIVATE MY BRACKET AND PROP CARD?

Brackets must be activated at Angel of the Winds Casino Resort to be eligible to win any prize.

Activate your Bracket by swiping your Players Club card at any promotional kiosk once, **March 16 – 22, 2026.**

Activate your Prop Card by swiping your Players club card at any promotional kiosk, **March 30 – April 3, 2026.**

### WHAT IS A \$100,000 PROP CARD?

The Prop Card is a 25-question quiz about the Semi-Final and Final Championship games played Saturday, April 4 and Monday, April 6, 2026. Try to predict the answers to the Prop Card questions by clicking on the answers you think will be correct.

### HOW LONG DO I HAVE TO CLAIM A PRIZE IF I WIN?

## **How to Play the Million Dollar Tournament Bracket Contest:**

Players Club members can participate in picking the teams of the scheduled NCAA Men's College Basketball Tournament that they think will win each of the games for their chance to win prizes. Guests will log in through the Engaged Nation Million Dollar March Mania website to pick from a list of teams playing in the tournament. The selections will follow the official NCAA Men's College Basketball Tournament schedule, excluding the Play-In games. Picks can be made online on Saturday, March 15, 2026, at approximately 7PM, after the teams are announced, through Wednesday, March 18, 2026, 11:59PM. Picks must be activated at a Promotional Kiosk, March 16 – 22, 2026, to be eligible to win any leaderboard prize. There will be 3 winners in weeks 1 and 2, and 5 winners in the season-long contest. In the event of a tie for weekly or season-long picks, the time the entry was submitted online is the tie breaker. The earliest submitted entry will be the winner. If an additional tie breaker is needed, a system generated random drawing will be held across all tied participants. These are the tiebreakers for all Bracket ties, excluding ties for perfect Brackets.

## **How to Play \$100,000 Prop Card Contest:**

Players Club members can try to predict the correct answers to a 25-question Prop Card, a quiz-style online game with questions pertaining to the Round of Four and Championship games in the NCAA Men's College Basketball Tournament. Prop Card picks can be made online Monday, March 30, 12AM through April 3, 2026, 11:59PM. Picks must be activated at a Promotional Kiosk, March 30 through April 3, 2026, to be eligible to win any Prop Card prize.

## **Game Rules:**

- Participants with an email address on file at the Players Club will receive weekly emailed invitations to play. Participants without an email address on file will register their email address and Players Club Card on the Engaged Nation Million Dollar March Mania Site.
- Players can access this site by scanning the various Marketing Materials on the casino floor.
- Participants will swipe their Players Club Card at a Promotional Kiosk to activate their Bracket and Prop Card picks.
- Participants will select the 'Million Dollar March Mania' to activate their picks.
- Guests can view their picks and view the correct number of Bracket picks made as leaderboards are updated, March 23, 30 and April 6, 2026.

be uploaded, and participants' scores will be calculated based on those results. The Bracket winners will be determined at these times.

- To win the one-million-dollar Bracket prize, a participant must make correct picks for every game of the NCAA Men's College Basketball Tournament, excluding the Play-In Games, for a perfect Bracket, and have activated those picks. In the case of two or more qualified participants making correct picks for a perfect Bracket, the winners will split the one-million-dollar prize equally among all winners, across all entities and contests participating in the insurance pool.
- In the event that a qualified participant makes correct picks for a perfect, activated Bracket, Engaged Nation reports the potential insured win to the prize insurance company, Tokio Marine HCC, who verifies the participants submitted picks. Once verified through the digital record of picks, payment of the win is processed and delivered to Angel of the Wind Casino Resort to present the prize to the winning participant.
